Dear Governor,

The undersigned Chambers of Commerce and Business Trade organizations are writing you to express our urgent concern with the announced planned strike of the SEIU 121 RN union at Riverside Community Hospital from December 24, 2020 through January 3, 2021. We believe you have the authority to halt this action under the California Emergency Services Act, and you share the moral obligation to speak out against it on behalf of the communities of which you have asked so much sacrifice since March of this year.

Under the current Regional Stay at Home Order, and in the interest of public health, chambers of commerce and communities across Southern California have a vested interest in protecting what precious little ICU capacity remains under the unprecedented surge of COVID-19 positive cases across the State. As you stated when issuing your Regional Stay at Home Order on December 3, 2020, "we are at a tipping point in our fight against the virus and we need to take decisive action now to prevent California's hospital system from being overwhelmed". Surely Governor this applies to our current situation. Nothing could be more debilitating to our regions capacity to fight this virus than a mass exodus of qualified healthcare personnel.

To be clear, we are not challenging or questioning the rights of these workers to collectively bargain, nor would we ask for your intervention were we not in extraordinary circumstances. Unions and management often disagree, and through the years have established practices and negotiating methods to achieve such means as they see right.

But now is not the time for a strike.

Over the course of this year you have asked, and in many cases ordered, small businesses and the community at large to bare a tremendous burden in the fight against COVID-19. We are asking that you use that same consistent voice, and power of your office, to speak out against and if required block, this unconscionable action on the part of SEIU 121 RN Labor Union that could endanger the lives of many in our region.

We are calling on you to please take the following actions:

- 1. State publicly that this strike is not in the public health interests of California and ask the union representing RNs at Riverside Community Hospital to call off their planned strike until such time as the COVID-19 state of emergency is lifted by your office.
- 2. Utilize the powers vested in you by the California Emergency Services Act to enjoin any such actions that would create a planned work stoppage on the part of the Registered Nurses at Riverside



Community Hospital, or any hospital inside of the State of California for so long as the State remains in a state of emergency under your orders.

We thank you for your continued leadership and look forward to your quick and decisive action to prevent this pending public health emergency.
